In hindsight, Christchurch's September 2010 earthquake, noted in the last *Newsletter*, was only the first in a series that has taken lives and destroyed many of the city's buildings, including churches. The Cathedral of the Blessed Sacrament, opened in 1905, was commissioned by Bishop John Joseph Grimes, designed by Francis William Petre, and constructed by William and James Jamieson. Petre adopted an Italian basilica style but placed the main copper dome above the sanctuary. Over time, the white Oamaru stone covering the concrete structure was damaged and discoloured by industrial pollutants. *(Continued on page 2)*

Bishop Brian Ashby authorized an extensive restoration programme that was begun in 1970. The project aroused public controversy because it included restructuring the sanctuary and removing the baroque high altar and reredos. These changes accorded with post-Vatican II liturgical norms – and the architect's original vision of an uncluttered liturgical space. The cathedral was registered by the Historic Places Trust in 1983 (category 1). Further cleaning and upgrading of the building's facilities were undertaken in the 1990s, and a forecourt was created. Unfortunately, the cathedral rests upon "a layer of old swamp mud and peat over gravel and silt". The seismic strengthening begun in 2004 proved unequal to the recent earthquakes, and the cathedral is now propped up by shipping containers while its ultimate fate remains under consideration.

### **CURRENT RESEARCH AND WORK IN PROGRESS**

Ali Clarke (ali.clarke@xtra.co.nz) has been working on various projects – a chapter for the *Spirit of the Past* volume, an article for the next issue of the *Journal of New Zealand Studies* ('Calendars, cemeteries and the evolution of colonial culture'), and her book on childbirth in 19<sup>th</sup> century New Zealand, to be published by Bridget Williams Books next year. She is now working on a joint project with Peter Lineham and John Stenhouse on the historical geography of religion in New Zealand.

Allan Davidson (ak.davidson@auckland.ac.nz) spent the first part of the year finalising the Auckland Anglican Diocesan history, *Living Legacy*, which was launched in May. The remainder of the year has been taken up in large part with editing the papers given at the 2009 Selwyn Symposium which is due to be launched 7 December. Laurie Guy (<u>laurie@carey.ac.nz</u>) Laurie Guy's 'big' publication (600pp.) has finally emerged this year: *Shaping Godzone: Public Issues and Church Voices in New Zealand 1840-2000*. Laurie has been doing further work on anti-Asian racism a century ago and gave a special lecture on this at the University of Otago in November. He is also looking at levels of media hostility to church voices on public issues in the recent past, with the question whether this is more intense than in previous decades.




