## **Preface**

This bibliography attempts to bring together research and literature relevant to multicultural and indigenous social work practice in New Zealand.

As a Subject Librarian for the School of Counselling, Human Services and Social Work at the Faculty of Education at the University of Auckland I am often asked to search for literature related to multicultural social work. New Zealand embraces a diverse range of racial, ethnic, and cultural populations and this can be a challenge for social workers as they approach their research and practice.

## Scope

I have concentrated on material published in, or about New Zealand but selected international material has also been included where this was considered relevant to the New Zealand situation.

Information is arranged by selected "fields of practice" subject headings and further by specific region, ethnic, racial or cultural group. References are presented in APA style.

Given the wealth of literature published about multicultural social work no one bibliography is ever likely to be comprehensive. I hope however that the material presented here will be of assistance to social workers as they attempt to increase their knowedge, skills and awareness of multicultural issues.

## Notes on the 2<sup>nd</sup> edition

This latest edition includes references to new material published in 2009 and 2010. A new topic heading has also been added: Poverty.
